1. Call to Order

- Towing has resumed since roofing project has concluded. Updated towing agreement signed by Director O'Connell.

 - Unclear what future costs may be for project, discussed tabling front gate issue until we can reassess HOA finances after roofing project is fully complete.
- Roofing: Roof replacement is completed, next stage is gutter and soffit replacement. McAuley Roofing has been paid for gutters and

soffits from funds in operating, will not need to issue special assessment.

5. Board Vacancy Appointment

- Joshua Kitner's seat on Board was deemed abandoned pursuant to Fla. Stat. 720.306(9)(b), Attorney notice to Kitner sent May 9, 2025. Vacancy to be filled.
 - o HOA property to be obtained from Kitner.
- Based on January 2025 meeting election, Director O'Connell moved for Tyler Acheson to be appointed to Board. Director Falger seconded.
- Kellie O'Connell to be President, Brenda Falger treasurer, and Tyler Acheson Secretary.
- Director O'Connell moved to make Mike Salviano chairman of grounds committee, Director Falger seconded, all in favor.

6. Landscaping & Tree Trimming Contracts

- Reviewed quotes for new landscapers, Lawns & Palms is most affordable at \$900 per month, new vendor is cheaper than current service provider, and appears to provide more services.
 - o Director Falger moved to change landscaper to Lawns & Palms.
 - o Director O'Connell seconded.
 - o All in favor.
 - o Director O'Connell signed agreement with vendor, new services to begin August 1, 2025.
 - Chairman Salviano approved to meet with vendor as grounds committee chair on behalf of Board, Chairman Salviano to provide updates to Board.

- Budget meeting goal for September or October 2025.
- Director O'Connell to meet with HOA Attorney about pending matters.
